| Pharmacy First | Service Income | February 2025 | Changes to the Pharmacy First payment thresholds have been made for the rest of the year. The threshold for February is 25. A minimum of 25 consultations are to be completed to pass the gateway point to be eligible for the £1,000 monthly payment. | |

| Advance Services Bundling | Service Income | 31 March 2025 | From 31 March 2025, community pharmacies must deliver a bundle of services to qualify for the monthly £1,000 payment. This includes: • Pharmacy Contraception Service • Hypertension Case Finding Service • Pharmacy First | |
| Pharmacy Profile Update | Contractual | 31 March 2025 | Ensure your Directory of Services and NHS website profiles are accurate by updating your NHS Profile Manager once each quarter; the deadline for this quarter is 31 March 2025 but we encourage you to do this as soon as possible | |
