Annual Complaints Report	Contractual	As soon as reasonably practicable after the end of 2024/25	Pharmacy owners must send a copy of their <u>annual complaints</u> report to the local NHS contract management team. This is a mandatory requirement for all pharmacy owners	
Pharmacy First Service	Service Income	31 March 2025	Deadline for pharmacy owners who are delivering Pharmacy First to also deliver the Pharmacy Contraception Service and Hypertension Case-Finding Service to qualify for the monthly £1,000 fixed payment (as well as meeting the relevant consultation threshold)	
NHS Pharmacy Profile Update	Contractual	1 April - 30 June 2025	Ensure your Directory of Services and NHS website profiles are accurate by updating your <u>NHS Profile Manager</u> once each quarter; the new quarter starts on 1 April and ends on 30 June 2025 but we encourage you to do this as soon as possible
